# 83/2019 Chair's Welcome & Housekeeping

# 84/2019 Public Participation / Cornwall Council report, if available.

**Sue Brownlow attended on behalf of St Keyne parish church** to discuss early proposals for using land which is adjacent to the church. The church is considering several options which may include leaving the ground as it is; creating an open community space or building affordable housing. Councillors asked questions about the site and location of the space, and raised concerns about the impact that building works might have on the listed building status and the surrounding area. Ms Brownlow explained that this was an early consultation and she would take councillors' concerns back to the church to assist their discussions. Cllr Sally Lewis suggested that it might be helpful for the church to run a survey to assess public opinion.

**Cornwall Councillor Phil Seeva presented his report**: today had been the first full council meeting with the new leadership team in place; further investment in broadband across the county worth £5m had been agreed; further consultations on improvements to the A38 were taking place; government funding for the Cornwall Spaceport at Newquay had been received; he welcomed the positive approach to boundary changes that had been taking place between St Keyne and Dobwalls & Trewidland parish councils.

#### A Cllr Jane Page

Maintenance report: a low hanging branch in Jubilee Park requires attention. Cllr Dorling agreed to attend to it; one incidence of dog mess at Longlands.

#### B Cllr Kevin Shovelton

Reported that he had been in touch with a resident in Trewidland to discuss ways in which they might share resources to improve footpath signage and maintenance.

#### 93/2019 Chair's Agenda Items

#### A Community Governance Review

The Chair presented the draft submission in support of a change to the adjacent parish boundary with Trewidland. Cllr Hugh Francis attended from Dobwalls & Trewidland parish council to confirm his council's support for the changes. It was RESOLVED to support the submission that will take in the settlement of Trewidland, increase the number of councillors in St Keyne to 9 and change the name of the council to 'St Keyne & Trewidland Parish Council', subject to an amendment that the enlarged parish council would not be warded. Proposed Cllr Sally Lewis. Seconded Cllr Dorling. All agreed.

#### B Longlands Recreation Area

Cllr Sally Lewis explained that the current lease on Longlands recreation ground that is due to expire in May 2021 will not be renewed. The owner of the site has been in touch to explain that they wish to reclaim the site as extra farmland. The existing hard standing can remain, but the remainder of the site needs to be made good before handover. Cllr Lewis thanked the owner for allowing the parish council use of the land, and asked councillors to use this as an opportunity to reassess the need for a second outdoor space in the parish. All agreed that Cllr Lewis should write an article for The Informer asking for residents' feedback on this and future open space provision.
