**Proceedings under Section 119 of the Highways Act 1980;
Preliminary Consultations;
Proposed Diversion of Public Footpath 18 in the Parish of St Keyne and
Trewidland;
Land at Landlooe House, Trewidland, Liskeard, Cornwall, PL14 4RT**

Background

Cornwall Council has received an application for the diversion of part of Public Footpath Number 18 in the Parish of St Keyne and Trewidland.

The application has been made by the owner of Landlooe House. At present, the route of Definitive Right of Way number 18 is obstructed by the applicant's house. The proposed diversion is necessary in order to create a practical route on the ground.

The proposal is shown on the enclosed map. It is proposed that the new path shall be at least two metres in width at all points. The alternative path will introduce two new limitations to the route: a field gate located three metres north of Point 'E', and a field gate located 4 metres north of Point 'F' on the plan. The Authority recognises that the path created by the confirmation of the Order would become a highway maintainable at the public expense.

The rights of Statutory Undertakers in respect of land where it is proposed to stop up a right of way would be preserved by the usual provisions contained in a Public Path Diversion Order.

General

Before Cornwall Council determines whether or not to exercise its power to make any Order as set out in the proposal, it is helpful to consult with all interested parties to gauge the likely public response.

I am writing to seek your views and I would be grateful if you would complete and return the enclosed decision slip to either the email address or postal address provided at the end of the page before **Friday 11th February 2022**.

If I do not hear from you by the above-mentioned date, I will assume that you have no objection to the proposals.
