Subject: RE: Outstanding matters

I've been able to speak to the Chair about your email and he thanks you for raising these issues with him. Your letter will be included in the agenda for next weeks meeting, but in the meantime, Cllr Shovelton has asked me to reply directly to your questions – I hope the answers will go some way to addressing your concerns.

From the outset, I need to explain that at the time of the change in boundary between Dobwalls parish council and St Keyne parish council, no issues were passed over or flagged as outstanding. The then Chair, Cllr Sally Lewis was keen to see much greater attention paid to Trewidland and its residents, and for this reason was delighted that there were four new local councillors elected to represent the ward. As part of that response, she met with those new councillors four weeks after the election to take their views on what Trewidland's residents felt their needs were. This led to a daytime walkabout in Trewidland on Saturday 31 July 2021 where councillors met with residents to introduce themselves and see for themselves what the issues were. After discussion at the next council meeting, an action plan was produced and all the topics listed have since been addressed.

The answers to your specific questions are:

1 We are not aware of this being an issue. Was the wall previously an issue that was being dealt with by the former Dobwalls & Trewidland PC? Perhaps as a complaint?

2 & 3 There appear to be a couple of places along that road where old cars and other items are being stored or dumped, we have assumed by the landowner. We will look into what scope we have to get the eyesore removed.

4 Councillors received an update at their April 2023 meeting (and published in the minutes) that:

The Chair reported that he had received an update from Cornwall Planning, that: following the dismissal of the appeal, officers would be visiting the site to ensure that the applicants had complied with the original enforcement notice.

5 The Chair will contact you about this. It has not been brought to our attention previously.

6 Footpaths: the Chair is very keen to maintain and restore footpaths across the parish. Fingerposts and directional signage is the responsibility of Cornwall Council. Where signs are missing, you can report them directly yourself using this link or you may prefer to talk to the Chair about this.

Apologies that am I writing this so close to today's meeting but I have been meaning to ask what, if any, outstanding issues were passed over from Dobwalls and Trewidland Parish Council.

From what I can remember the following outstanding issues were previously raised.

1: New wall built at Rosenun which protrudes into the road, presumably to try to retain chippings at entrance.

2. Land towards Liskeard, just passed the hunting hounds, being used as dumping ground, believed to be related to Nick Dyson.

3. Land Trewidland side of hounds also looking like a caravan graveyard.

4. What happens with enforcement notice EN22/00763 now that planning application and appeals have been refused. It appears that climbing frames, swings and skate ramps have also recently been erected.

5. Land near Lake, about an acre of woodland cleared, caravans on site and postbox has appeared which would suggest someone is living there. Cannot find any planning or change of use has been sought.

6. How do we go about opening and signing footpaths in the parish in light of the new NDP. Some posts were erected by The Ramblers many years ago but still await fingerposts. Some paths have obstructions.

I have photos but I cannot work out how to reduce the file size to be able to send. Will try to have a look again later.
