Cornwall Councillors Jane Pascoe reported that: she thanked the parish councillors for welcoming her to their meetings, and explained that the full Cornwall Council meeting next Tuesday would be her last in the current administration; the number 11 bus service from Liskeard to Bodmin (hospital) had been withdrawn although she had lobbied to retain it; the current Liskeard to Plymouth service would run with increased capacity due to increased demand; congratulated the council on its parish magazine (The Informer).

Cllr Armand Toms was present at his final meeting due to his retirement from public service, and reported that: tolls on the Tamar Bridge will rise for all vehicles from 25 March, with fares for cars and vans to go up from £2.60 to £3.00, and fares for Tamar Tag holders to rise from £1.30 to £1.50; he thanked the Chair and councillors for also welcoming him to their meetings over the past four years since the merger between St Keyne and Trewidland; he always looked forward to a lively and engaging debate and discussion. The Chair thanked him for his service and wished him well in the future.

# 008/2025 Chair's Report

# A Looe Valley Festival April 2025

This council's contribution would be a free viewing of the film 'Six Inches of Soil' on Friday 11 April at 7pm in St Keyne Village Hall. Of the 60 available seats, 47 had been booked, and we expected a full house on the night. Hot food would be provided by Cllr Lindsey Ellis. Full report at May meeting.

# B Community Emergency Plan

Cllrs Shovelton & Hopwood agreed to meet on 1 May at 10am to redraft the current plan. Councillors asked that new scenarios should be included: road flooding, fallen trees and fires near fields. Also, a realistic assessment of what facilities the parish council could provide.

# C Footpaths Working Group

Chair has met with the group to review the progress in preparing an application to CC to modify the Definitive Map and in obtaining witness statements that provide evidence of historic use of the footpath that runs across the railway line to the road near Lower Reedy Mill. They plan to meet on 8 May 2025 to finalise the application paperwork before submitting it to Cornwall Council. The group has also agreed to review the current scope of footpaths maintenance in Trewidland. *Action: Clerk to pass contact details of current contractor to Chair to organise a site meeting.* 

# 009/2025 Councillors Reports

# A Cllr Woodman

Trewidland Village Hall continues to organise new events for residents that will now include a Treasure Trail (10 May) and Summer Fete (5 July). More details as they become available.

# B Cllr Featherston

Reports that the old bench in Jubilee Park has been removed and the replacement will be installed on Saturday 12 April and has replaced the latch on the play areas entrance gate.

# C Cllr Hopwood

Presented proposals to organise a summer Produce Show that will encourage young people to grow flowers and vegetables by donating seeds and other growing materials. The Show will be open to all children under the age of 11 at school or living in the parish. Councillors **Resolved to** 

**provide a budget** of up to £350 for the purchase of materials. Proposed Cllr Hopwood. Seconded Cllr Shovelton. All agreed.

Action: Cllr Hopwood to purchase materials and promote the project throughout the parish.

#### D Cllrs Featherston & Cluer

Reported that they had successfully recruited volunteers from the Green Team and friends to plant out up to 6 fruit trees in a new community orchard in Jubilee Park this autumn. Funding is available from Cornwall Council. Councillors thanked them for their work on this project.
