066/2025 Public Participation

A resident attended to raise issues arising from the fire at Lean Quarry in August 2025, and asked that the pending review of the council's Community Emergency Plan include provision for improved communications between residents and the parish council should a situation of similar impact occur again. They also asked that discussions with the responsible owner (Biffa Waste Management) should include funding and other support for those parts of the community most affected. Cllr Pascoe explained that the site of the fire lay within the division of Cllr Mark Gibbons: she would pass the resident's concerns onto him. There were quarterly residents meetings between Cornwall Council and Biffa, and she would raise the issue on the next occasion. Action: Clerk to include this topic in discussions with Cllr Shovelton

Cornwall Councillor Jane Pascoe reported that: she had raised the issue of increased parking charges with responsible officers at Truro, and was hopeful that they would be decreased in the coming budget calculations; is lobbying for a reduction in the target for new housing in the county because of the lack of land, materials, infrastructure and skilled labour; continues to campaign for improved bus services in the parish, especially for those connecting to Derriford Hospital; thanked councillors for attending the Area Partnership meeting on the previous evening, and reminded that the January meeting would be face to face (venue to be agreed) and the April meeting online; attended celebrations to mark the 50th anniversary of twinning between Quimperle (NW France) and Liskeard and encouraged this parish to consider its involvement with the scheme; noted that new regulations governing the licensing of hackney carriage/private hire vehicles came into effect in July 2025.
