### **004/2026 Public Participation**

Nicky Fairey from Trewidland Village Hall attended to present findings of her recent user survey that overwhelmingly supported the building of new premises with commitments to fundraise and extend its usage.

Cornwall Councillor Jane Pascoe reported that: her ward had suffered no structural damage in the recent Storm Goretti, although the loss of internet connections in Trewidland remained a problem; the proposed 150% increase in the Tamar Tag admin fee from 80p to £2 per month has been reversed for now pending a review and consultation; encourages residents to engage with the off-street parking survey that launches today; the next Community Area Partnership meeting on 7 April welcomes residents as well as councillors and officers; attended the recent funeral of former parish councillor Loveday Carlyon; has funding remaining in her Community Chest that is open for applications.

Cornwall Councillor Mark Gibbons reported that: also has funding remaining in his Community Chest that is open for applications; recent graffiti in Looe has been removed, with police examining CCTV footage for the perpetrator; Storm Goretti brought down several trees and caused some damage in Looe; Morval and Widegates were affected by power cuts, since now restored; Cornwall Council's draft budget for 2026/27 is open for public comments; Visit Cornwall (the county tourist organisation) entered liquidation at the end of 2025, but the county council has committed to maintaining its website;

Cllr Gibbons left the meeting at 8pm.

Proposal Installation of Helios Fire Suppression Unit

Location Biffa Waste Services Materials Recycling Facility Lean Quarry Horningtops Liskeard

### **PA25/08339**

Proposal Change of use of land at Brimboyte Bungalow to private dog exercise area.

Location Brimboyte Bungalow Horningtops Liskeard.

It was **Resolved to support this application**. Proposed Cllr Jonathan Ellis. Seconded Cllr Hopwood. All agreed. In making their decision, councillors noted that this was an application for a commercial venture and not a private one. Potential light pollution was not considered to be an issue.

### **PA25/08452**

Proposal Construction of stables, storage shed and associated landscaping.

Location Land At Stocks Lane Trewidland Liskeard PL14 4ST

It was **Resolved to support this application**. Proposed Cllr Whiting. Seconded Cllr Cluer. All agreed. In making their decision, they asked that the planning officer to record their concerns that:

- The facility should only be available for private and not commercial use.
- The correct address of the development site is Knilly Lane
- Policy RT2 of the Dobwalls & Trewidland Neighbourhood Plan should be applied.
- Councillors view was that the area of land allocated on the site was insufficient to support 6 horses (concerns about soil erosion) and that there were no adequate plans in place to manage or dispose of the associated farm yard manure (the sections marked 'waste storage and collection' and 'trade effluent' were indicated as 'no')
